### **Background**

Today prisons are increasingly multi-ethnic environments. Cultural and ethnic diversity of inmates pose multiple challenges to front-line prison staff, who have to cope with cultures and languages unknown, “sub-culture” phenomena and possible episodes of radicalization and extremism. The management of multi-cultural aspects in prison facilities is a priority issue in the EU legislation, as highlighted by the Recommendation CM/Rec(2012)12 of the Committee of Ministers, which calls for the need to provide prison staff with proper training to deal with foreign prisoners’ needs and rights. In this framework, the 2-year project B-COMPETENT. Boosting competences in Penitentiary Staff in Europe aims to contribute to an effective and coherent application of EU laws and standards on the treatment of foreign prisoners by designing and implementing a train-the-trainers program (face-to-face and e-learning), combined with best practices sharing, awareness-raising actions and practical multilingual tools. The Albanian Ombudsman in collaboration with 6 partners, are implementing the project no. 854040 “*Boosting competences in Penitentiary Staff in Europe*” co-funded by the European Union’s Justice Programme (2014-2020)

### **Objective**
